Cooperative's 77th annual meeting

THE cooperative's 77th annual meeting will be held Wednesday, April 13, 2016, at the Crossroads Bible Church, which is located 2.5 miles north of the Bedford Turnpike Interchange on Business Route 220 near Cessna. Registration starts at 12:30 p.m., and the meeting begins at 1:30 p.m.

During the registration hour, attendees may take advantage of free blood pressure screening. Light refreshments will be served, and every registered member will receive a gift. Be sure to visit the display area, which will be devoted to new trends in the electric business.

Local Christian-country music favorite John Topper will provide the entertainment. Topper is well known as a retired teacher and coach who continues to provide sports commentary on local radio. But, he is perhaps best known for his deep, distinctive voice that has been entertaining crowds since the 1970s at fairs, churches, nursing homes and rodeos. Cuppett Covered Bridge good as new

IN February 1881, three New Paris residents signed a docket to build a covered bridge below Steck's Mill near New Paris where the road from Schellsburg to Pleasantville crossed Dunnings Creek in Napier Township. The docket was signed by G. W. Williams, William Egolf and Cornelius Whetstone.

The road is no longer there, so the initial reason for the bridge's existence disappeared along with it sometime in the 1950s. The structure of the bridge, completed in 1882, remained and is now a part of the original farm owned by Charles Cuppett.

Charles' son, Cecil, who lives on the farm, became concerned because the bridge, while picturesque, was falling into disrepair.

"I was afraid it was just going to

tumble into the stream," he says.

At least twice in Cecil's lifetime, the bridge was set on fire by pranksters. Many of the boards were falling off, ceiling timbers were rotting, and the foundation was crumbling.

Taking his problem to Imler II Construction, Cecil sought the expertise of Randy and Trey Imler and David Dodd. They began renovating the bridge in 2015.

"They're New Paris boys," Cecil says. "They were eager to help. I agreed to provide the funding and oversee the project, and they did the labor. It was pretty much a work of love."

The fires meant new floor boards were needed, but because vehicles cannot drive across the bridge, it does not have to have boards running lengthwise of the structure. Cecil does not mind if pedestrians cross the bridge to enjoy the view or look down into the stream.

The men also installed a couple of braces under the roof. Since there never were boards going the entire way to the top, it has remained that way. Cecil also decided to leave it unpainted, as that is the way he remembers it from years ago. Stone pillars holding the bridge in place were put back into their original condition.

"The guys knew what they were doing and we engineered as we went along," Cecil says.

During the summer, the men replaced the worn-out boards with treated lumber and by fall, the bridge was nearly back to its original condition.

Total project cost was \$14,100, a bit more than estimated, but still within reason. Cecil says he expects the renovated bridge will last well beyond his lifetime and maybe even the lifetime of his three daughters, Cozette, Katie, and Kimberly.

Katie Cuppett Bringuier, who lives in California, is so proud of the New Paris Cuppett history that she has developed a website at www.Cuppetthistory.org. It begins with John Cuppy, then Daniel Cuppett, Isaac Alexander Cuppett, William Washington Cuppett, John Albert Cuppett, the Cuppett Brothers (the six sons of John Albert), Phoebe Elizabeth Cuppett and Cecil Cuppett III (children of the youngest of the Cuppett Brothers), and the eighth generation, the Cuppett sisters (Katie and her sisters, Cozette Cuppett and Kimberly Cuppett).
